The total amount of financing on Agreement on International Adoption Program between Happy Child Association and the Adoptive parents through the Adoption Agency is **12 474 BG leva** and is paid in four payments:

- **Advance payment of 2000 BG leva** (two thousand leva) - *due at signing of the Agreement;*
- **Second payment of 3000 BG leva** (three thousand leva) - *due by the adoptive parents/the adoption agency at the sending of a report by the Ministry of Justice including a referral of a particular child to the adoptive parents. This payment is due before the moment of establishment of a personal contact between the adoptive parents and the referred for adoption child and should precede the date of their arrival in Republic of Bulgaria;*
- **Third payment of 5200 BG leva** (five thousand and two hundred leva) - *due by the adoptive parents at the signing by them of a notarized written consent for adoption of the referred by the Ministry of Justice child;*
- **Fourth payment of 2274 BG leva** (two thousand two hundred and seventy four leva) - *due by the adoptive parents in the moment of coming into force of the degree allowing the adoption of a child – Bulgarian citizen of the adoptive parents.*

**\* The financing on the Agreement on International Adoption Program is agreed in BG currency. The exact value in Euro of each of the four payments under the Agreement is determined according to the exchange rate of the Euro to the BG currency, which is 1 Euro to 1.95583 Bulgarian leva.**

**\* The fee above is for the adoption of one healthy child up to the age of 7 years. For the adoption of special need children and children older than 7 years of age, we always decrease the fee with 2000 BG leva. For the adoption of 2 healthy children at the age up to 7 years of age, we increase the fee with 2000 BG leva.**

**\* The fee above covers all the expenses in Bulgaria connected with the adoption procedure – fees, state fees, translation, transportation of the adoptive parents with transport of Happy Child, accompanying of the adoptive parents during their visits to Bulgaria and all the expenses of the accompanying person while with the adoptive parents (fees, food, accommodation, etc. of the accompanying person). This fee covers all the fees for representation of the adoptive parents before all the institutions and bodies in Bulgaria.**

Please, note that:

- The adoptive parents are solely responsible for covering of all their travel expenses out and to Bulgaria, including the expenses of the adopted child when leaving Bulgaria and out of Bulgaria, including but not limited to: plane tickets, airport fees, exit fees, as well as for covering of the following expenses in Bulgaria for themselves: hotel accommodation, food, medical exams, medicines, entertainment,

tour-guides, and insurance.

- Happy Child Association covers the transportation with a car of the Association of the adoptive parents from Sofia to the town/village where the child lives and back, and in that town/village, during the 1-st visit to the child for the obligatory 5-day contact of the adoptive parents with the child, and accordingly covers the transportation with a car of the Association during the 2-nd visit of the adoptive parents for picking up of the child at the end of the adoption procedure.
- Happy Child Association ensures interpreter / interpreter and companion of the adoptive parents during both visits to Bulgaria, i.e. for realization of the 5-day contact with the child during the time of the 1-st visit of the adoptive parents to Bulgaria (meeting the adoptive parents at Sofia airport and accommodating them to a hotel, transportation to the town/village where the child lives and back, assistance and accompanying during the visit and contact with the child and the orphanage/social services staff, preparation, assistance and accompanying during signing of the necessary papers, bringing the adoptive parents back to Sofia airport), accordingly during the 2-nd visit of the adoptive parents for picking up the child (meeting the adoptive parents at Sofia airport and accommodating them to a hotel, transportation to the town/village where the child lives and back together with the child, accompanying them while in Sofia, bringing the adoptive parents with the child to Sofia airport) – **the expenses of the interpreter / interpreter and companion (accommodation, food, fees, etc.) are fully covered by Happy Child Association.**
- Visits to the child out of the above mentioned 2 visits are possible with preliminary consent of the director of the orphanage/social services and Happy Child Association. The adoptive parents cover all the expenses during such visits, including but not limited to: transport, hotel (for themselves and for the interpreter / interpreter and companion), fees, traveling expenses, as the fees and the other expenses are stipulated in addition.
- The adoptive parents agree that all visits to the child are made always and only with the knowledge and cooperation of Happy Child Association.
